Thank you for agreeing to serve as a discussant for the 38th EAST Annual Scientific Assembly. Below is some information for you as you begin to prepare for your participation at the meeting.

Cox-Templeton Injury Prevention Paper Competition Presentations: Discussions will be delivered from a podium next to the moderators' table. **Please limit your discussion to three (3) minutes**. The discussion time should be used to put the study results into context of existing literature and/or clinical practice, and NOT to re-present the results. <u>The discussion should NOT start with</u> <u>repeating the study data or findings</u>, as these were just presented by the author and do not need to be repeated. Questions for the presenter should be clear and limited to a number that can be handled in a timely fashion (no more than 3-4 questions) and leave time for questions from the floor. The presenter will answer your questions directly after your discussion (not after an additional discussion from the floor). Ideally, this will place the onus on the presenter to actually answer the questions that are asked.

Manuscripts: All Oral/Podium authors have been instructed to submit their manuscripts directly to discussants by December 31, 2024. If you do not receive the manuscript by December 31, 2024, please contact Christine Eme, <u>ceme@east.org</u>, in the EAST Administrative Office.

Registration: All Discussants are expected to register for the meeting and pay appropriate registration fees. Registration information for the 38th Annual Scientific Assembly is available on the EAST Website. Visit the <u>Annual Scientific Assembly page</u> for program details and registration information. EAST does not offer one day registration.

Meeting/Presentation Attire: The founders of EAST remind us that the scientific meeting is meant to be informal (no more formal than business casual). EAST prefers Hawaiian shirts or casual attire even while you are presenting.

Disclosure: Everyone who is on the program of our assembly (including discussants) is required to complete a disclosure statement, even if you have nothing to disclose. If you are fulfilling multiple roles on the program (e.g. Discussant, Moderator, Presenter), please complete the form posted on the <u>Information for Presenters</u>, <u>Discussants</u>, and <u>Faculty page</u> taking into consideration your role(s) and disclosure as *it pertains to the content of the presentation(s) that you will be giving, moderating, or discussing*. Please complete by the requested deadline. We must have all disclosures on file for CME to be awarded.
