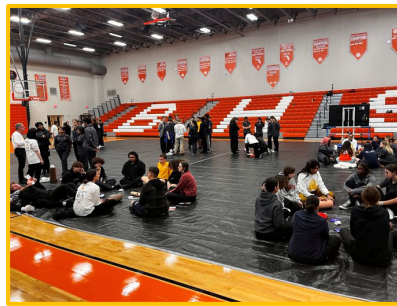

#### **The Two Hit Hypothesis of EGS: Navigating Surgical Emergencies in Patients with Advanced Co-morbidities**

Emergency General Surgery (EGS) is a pillar of Acute Care Surgery (ACS), in which surgeons are asked to operate on complex surgical emergencies in critically ill patients, who often have severe underlying co-morbidities or terminal conditions. This includes, but is not limited to, metastatic cancer, advanced cirrhosis, and decompensated heart failure. This educational session serves to equip ACS surgeons, residents, and advanced practitioners with the knowledge to navigate these complex EGS cases, including patient selection, techniques for operative intervention, opportunities to engage Palliative Care, and communication strategies in order to set appropriate expectations for these patients. **Healing as a Team: Navigating Alcohol Use Disorder**

Alcohol use disorder (AUD)\* affects surgeons across all ages, racial and ethnic backgrounds, sexual and gender identities, and socioeconomic backgrounds. This session will focus on recognition of the disease, steps to intervene, and what to expect once treatment and recovery has started. ### **So You Want To Be A Division Chief**

*Presented by the EAST Mentor Member Committee*

This session is designed to address four specific areas that all Division Chiefs must be fluent in the skill set to be successful and effective as a leader. Key factors in how to develop a proforma for a potential position on your team, including the inside scoop as to what the C suite is looking for to see the position as valuable will be presented. Graduating fellows are well versed in the medical aspects of the ICU, but the best practices and policies will be completely ineffective if the ICU Medical Director does not understand the forum to onboard the rest of the multi-disciplinary team. The session will provide insight into the nuts and bolts of getting leadership of Nursing, RT and Rehab to buy into care initiatives and how to implement change for bedside care, not just on paper. The EMR is here to stay. As compliance and administration add to the requirements for documentation, one's day can be consumed by the EMR. Tips and tricks to making the EMR more efficient will be presented. Attendees will be able to immediately translate the take home lessons into time saving opportunities to complete requirements and give the learner one of the most important commodities, time. Compensation is often equated to salary when compensation really encompasses many other factors. **Short Course #1 – Robotic Applications Across the Spectrum from Elective to Emergency Surgery**

## Trauma Performance Improvement Workshop

*Presented by the Trauma Center Association of America & supported by the EAST Quality, Safety & Outcomes Committee*

**Overview:** Performance Improvement is one of the areas required to meet the standards of verification/designation of trauma centers. The verbiage of loop closure is one of the main concepts in a PI Plan and critique during a verification/designation (Mowry, 2019). In an eBook by Trauma System News (2016), Dr. Michael McGonigal revealed the importance of documentation and its effect on verification status. This workshop will be open to all to all trauma surgeons, APPs and the trauma program team who provide and review trauma care. The scope of the workshop is for the Trauma Program Team to learn how to improve PI operations in their trauma center and exert control over their process. The faculty will focus on PI topics relevant to developing, managing, or improving the PI process and care in their trauma center.

1. Demonstrate an in-depth understanding of trauma PI program structure and flow.

## CODE OF CONDUCT FOR EAST MEETINGS

**1. Introduction.** The Eastern Association for the Surgery of Trauma (“EAST”) is a nonprofit corporation, organized for charitable, educational, and scientific purposes. In particular, EAST: (i) fosters advances in the study and practice of the surgery of trauma; (ii) provides a forum for the exchange of knowledge pertaining to injury control, research, practice, and training in prevention, care, and rehabilitation of injury; and (iii) advances research, education, and training regarding the prevention, correction, and treatment of injuries (“Exempt Purpose”). In furtherance of its Exempt Purpose, EAST conducts and/or sponsors educational meetings including, without limitation, Annual Scientific Assemblies and periodic internal and external meetings and programs (collectively “Meeting(s)”).

EAST seeks participation in its Meetings by individuals with varied and diverse backgrounds. EAST is committed to providing a friendly, safe and welcoming environment for all Meeting attendees, regardless of gender, sexual orientation, ability, ethnicity, socioeconomic status, religion (or lack thereof), and other individual characteristics. This Code of Conduct (“Code”) outlines EAST’s expectations of its Meeting attendees (including EAST members, EAST Board members, sponsors, invited guests, and any other person attending a Meeting), as well as the consequences for Unacceptable Behavior (defined below). We expect all Meeting attendees will abide by this Code at all Meetings, and in connection with activities outside of Meetings when such behavior has the potential to adversely affect the safety and/or wellbeing of Meeting attendees.

**2. Expected Behavior.** EAST expects its Meeting attendees will:

- Exercise consideration and respect in their speech and actions.
- Attempt collaboration before conflict.
- Refrain from demeaning, discriminatory, or harassing behavior and speech.
- Be mindful of their surroundings and fellow attendees.
- Be respectful to all patrons at Meeting venues.

**3. Unacceptable Behavior.** “Unacceptable Behavior” EAST will not tolerate includes, without limitation:

- Violence, threats of violence, or violent language.
- Disruptive, intrusive, insulting, antagonistic, or any other malicious conduct.
- Sexism, racism, homophobia, transphobia, or other discriminatory conduct.
- Inappropriate photography or recording.
- Inappropriate physical contact.
- Unwelcomed sexual attention and/or advances; including, using sexualized language.
- Intoxication, contributing to inappropriate behavior.
- Deliberate intimidation, stalking or following (online or in person).
- Sustained disruption during Meeting events, including talks and presentations.
- Advocating for, or encouraging, any of the above behavior.
- Any other conduct deemed inappropriate and/or that may jeopardize the success of a Meeting, EAST’s reputation and goodwill, or the positive experience of any other Meeting attendee.

**4. Consequences of Unacceptable Behavior.** Unacceptable Behavior by Meeting attendees will not be tolerated. The determination of whether conduct constitutes Unacceptable Behavior, and the consequences imposed by EAST for the same, rest solely within EAST’s discretion, and said determinations are final and not subject to appeal. Anyone asked to stop Unacceptable Behavior is expected to comply immediately. If a Meeting attendee engages in Unacceptable Behavior and/or does not comply with this Code, EAST may take any action deemed appropriate, up to and including a temporary ban or permanent expulsion from a Meeting without warning (and without refund, in the case of a paid event).

**5. Reporting Guidelines.** If you are subject to, or witness, Unacceptable Behavior, or have any other concerns, please notify EAST as soon as possible by contacting EAST’s Executive Director or EAST’s Executive Committee. If the subject Unacceptable Behavior involves the Executive Director, please notify EAST’s current President. Additionally, Meeting organizers are available to help Meeting attendees engage local law enforcement, or to, otherwise, help those experiencing Unacceptable Behavior feel safe. During Meetings, organizers are available to provide escorts as desired to the Meeting attendee(s) experiencing distress.

## Hold Harmless Waiver

The Eastern Association for the Surgery of Trauma ("EAST") 38<sup>th</sup> Annual Scientific Assembly ("Event") will be held in Tucson, Arizona at the JW Marriott Tucson Starr Pass Resort and Spa ("Premises"). In consideration of being permitted by EAST to participate in the Event and in recognition of EAST's reliance thereon, the individual named below (referred to as "I" or "Attendee") agrees to all the terms and conditions stated in this release ("Release").

1. I am aware of the contagious nature of bacterial and viral diseases including the 2019 novel coronavirus disease (COVID-19) ("Disease") and the risk that I may be exposed to, or contract the Disease or other infectious diseases by traveling to and from, and participating in, the Event and otherwise being on the Premises. I understand and acknowledge that such exposure or infection may result in illness, personal injury, psychological injury, pain, suffering, temporary or permanent disability, death, and/or financial loss. I understand that EAST cannot guarantee that I will not become infected with the Disease or other infectious diseases while on the Premises or participating in the Event and that being on the Premises or participating in the Event may increase my risk of contracting the Disease. NOTWITHSTANDING THE RISKS ASSOCIATED WITH THE DISEASE, I ACKNOWLEDGE THAT I AM VOLUNTARILY ENTERING THE PREMISES TO PARTICIPATE IN THE EVENT WITH KNOWLEDGE OF THE DANGER INVOLVED. I HEREBY AGREE TO ACCEPT AND ASSUME ALL RISKS OF ILLNESS, PERSONAL INJURY, PSYCHOLOGICAL INJURY, PAIN, SUFFERING, DISABILITY, DEATH, AND/OR FINANCIAL LOSS RELATED TO THE DISEASE, ARISING FROM MY BEING ON THE PREMISES OR ATTENDING THE EVENT, WHETHER CAUSED BY THE ORDINARY NEGLIGENCE OF EAST OR OTHERWISE.

2. I hereby expressly waive and release any and all claims, now known or hereafter known, against EAST, and the American College of Surgeons, and each of their officers, directors, employees, volunteers, contractors, agents, affiliates, representatives, members, successors, and assigns (collectively, "Releasees"), on account of personal or psychological injury, illness, pain, suffering, disability, death, or financial loss arising out of or attributable to my being on the Premises or participating in the Event and being exposed to or contracting the Disease, whether arising out of the ordinary negligence of EAST or any Releasees or otherwise. I covenant not to make or bring any such claim against EAST or any other Releasee, and forever release and discharge EAST and all other Releasees from liability under such claims. This waiver and release does not extend to claims for gross negligence, willful or wanton misconduct, or any other liabilities that Illinois law does not permit to be released by agreement.

3. I am familiar with federal, state, and local laws, orders, directives, and guidelines related to the Disease, including the Centers for Disease Control and Prevention ("CDC") guidance on the Disease. I will comply with all such orders, directives, and guidelines while on the Premises or participating in the Event, including requirements related to hand sanitation, social distancing, contact tracing, and use of face coverings. I will also follow all instructions of EAST and the operator of the Premises while participating in the Event related to health and safety measures. I understand that upon arrival at the Premises, I may be required to satisfy certain health protocols set by EAST as a condition for ENTRY, such as presenting proof of full vaccination against COVID-19, or a negative COVID-19 test. I acknowledge that if I do not present the documentation required by EAST or otherwise cannot satisfy the health protocols, I will not be permitted to enter the Premises or attend the Event.

4. I confirm that if I am experiencing symptoms of the Disease (such as fever or chills, cough, shortness of breath or difficulty breathing, muscle or body aches, new loss of taste or smell), or have a confirmed or suspected case of the Disease, I will not attend the Event.

5.
